#### CLAUSE 1





#### 3.5 TERM & TERMINATION

This arrangement shall remain in force for a period of 60 days from the date of signing and can be terminated by giving a written notice period of 15 days by either party.

Each party shall have the right to terminate this Agreement, by a prior notice of 15 days in writing to the other party upon the occurrence of any of the following events;

- a) If either party commits any willful breach of any terms stipulated in this Agreement and has failed to rectify the same within notice period of 30 days. The parties shall be responsible for conducting the training for the students enrolled before the termination of the contract.
- b) If either party enters into liquidation whether compulsory or voluntary (save for the purpose of amalgamation or reconstruction) or makes an assignment for the benefit of or compounds with its credit or so has a Manager or Receiver appointed in respect of all or any part of its business or a petition for winding-up or judicial management is presented against the other party or the other party ceases to carry on any part of its business or threatens to do any of these things.

On the expiry or termination of this Agreement, all rights and obligations of the parties shall automatically terminate except; -for such rights of actions that have accrued prior to such termination and any obligations, which expressly or by implication are intended to come into or continue in force.

#### 4. FORCE MAJEURE

Neither Party shall be liable for any default or delay in the performance of its obligations if and to the extent such default is caused, directly or indirectly, by fires, floods, power failures, Acts of God, act of public enemy, civil commotion, sabotage, wars, insurrections, riots, labour disturbances, strikes, lockouts, go-

slow, damage to machinery on account of accident or passing of any statutory order by the eligible authority/ies, prohibiting performance of such obligation by a competent authority; and restrictions of any country affecting the performance of this agreement or any part hereof. In the event of the occurrence of any of the foregoing, the date of performance will be deferred for a period of time equal to the time lost by reason of the delay. The affected party shall intimate the other party within reasonable time period of such occurrences.

#### LIMITATION OF LIABILITY

Notwithstanding anything to the contrary in the Agreement, in no event shall either Party be liable, whether in contract, tort, or otherwise, for special, punitive, indirect or consequential damages, including, without limitation, loss of profits or revenues arising under or in connection with this Agreement even if such Party has been advised in advance of their possibility. The Total Liability of MANAC INFOTECH shall be limited to the total fee received under the Agreement.

## 6. DISPUTE RESOLUTION MECHANISM

Any lack of understanding to the spirit and implementation of this Agreement will be resolved by mutual consultation by the Parties. In case parties fail to resolve the dispute by mutual consultation within 30 days of rising of dispute, the same will be resolved through Arbitration in terms of clause 7 below.

#### 7. ARBITRATION

In case the dispute remains unresolved, the same shall be referred to the Arbitration in accordance with Arbitration and Conciliation Act, 1996 after giving the notice of such reference to the other party. The matter shall be referred to the sole Arbitrator mutually appointed by the parties. In case the parties fail to appoint the sole arbitrator, the same shall be appointed by the High Court of the concerned State. The venue of the arbitration shall be Hyderabad and the language preferred will be English. The award of the sole Arbitrator shall be final and binding on the parties.

#### 8. GOVERNING LAW

This MOU shall be governed and construed in accordance with the laws of India and the courts of Hyderabad shall have the exclusive jurisdiction to entertain any dispute or suit arising out of or in relation to this Agreement.
