CONSTITUTION

1. Name : a) The Name of the Society shall be the NEW LOYOLA MODEL EDUCATION SOCIETY.
b) And it shall here in after be referred to an Society.
2. Office : The Office of the Society shall be located in Vanasthalipuram, C.77/MIG, Vanasthalipuram, Hyderabad, 500 035.
3. Membership: Any person who has completed the age of (21) years and is interested in education and welfare of boys and girls shall be eligible for the membership of the Society.
4. The Society may consist of the following classes of Members:
 - i) Founder Members.
 - ii) Patrons
 - iii) Donors
 - iv) Life Members
 - v) Ordinary Members.



6. PATRONS:

Such persons as the Executive Body may invite from time to time may on acceptance of invitation become the Patrons of the Society on payment of Rs. 2,000/- (Rupees in words Two thousand only) or more donation to the Society. Patrons shall be entitled to all the rights and privileges as enjoyed by the ordinary members of the Society.

7. DONORS:

Such persons as the Executive Body may invite from time to time, may on vitation, become the Donors of the Society on pygment of Rs. 1,000/- (One Rupees in words One thousand only) or more as donation to the Society. Donors shall be entitled to all the rights and privileges as enjoyed by the ordinary members of the Society.

8. LIFE MEMBERS:

Any person who pays Rs. 500/- (Rupees in words five hundred only) or more and is otherwise eligible for membership of the Society may admitted by the Executive Body as a life members Life members shall be entitled to all the rights and privileges as enjoyed by the ordinary Members of the Society.



9. ORDINARY MEMBERS:

Any person, who is otherwise eligible for the Membership of the Society may be admitted by the Executive Body by paying the admission fee of Rs. 25/- (Rupees in words Twenty Five only) or such sum as may be prescribed by the Executive Body from time to time. 10. MODE OF ADMISSION OF MEMBERS:

Every person for admission as a Member of the Society shall be proposed by one and seconded by another member of the Society. The proposal for the Membership shall be in such form as the Executive Body may prescribe from time to time.

11. DISQUALIFICATION FOR CONTINUING AS MEMBER OF THE SOCIETY:

A member shall cease to be a member of the Society in the following circumstances:

- a) On resignation or Death.
- b) If he is adjudged as insolvent by a competent Court or sentenced to imprisonment for any period involving moral turpitude.
- c) On his failure to pay arrears or subscriptions, for a period of one year due to the Society in case of ordinary Members.
- d) Any person found working against the aims and objectives of the Society whether directly or indirectly, to be decided by the Executive Body.


12. SUBSCRIPTION:

Notwithstanding anything contained in these articles the Executive Body may at any time and from time to time, determine, increase, reduce, alter, modify or vary the admission fee, annual subscription and subscription for life members, donors Patrons.


13. GENERAL BODY:

14. GENERAL BODY MEETING:

The General Body of the Society shall meet atleast once in a year i.e., in the month of March for the purpose of consideration of:-

- a) The Annual Report of Executive Body on the affairs of the Society.
- b) Election of the members of the Executive Body every third year.
- c) Such other proposals or matters as the Executive Body may take or bring before the General Body.

15. Notice of the General Body Meeting shall be given atleast 7 (seven) days before the date of the Meeting.

16. OCURUM OF THE GENERAL BODY:

- 1. The Quorum for a meeting of the General Body shall be one-third of the total strength.
- 2. Once the General Body meeting is Post-poned for want of Quorum, the condition of Quorum, the condition of Quorum shall not be necessary for the subsequent meeting.

17. EMERGENCY GENERAL BODY MEETING:

- i. The President or behalf of himself or on the written requisition of the one-third members of the Executive Body or General Body shall convene the emergency General Body Meeting.
- ii. The decision taken by an emergency General Body Meeting shall have the same force and effect as that of annual General Body Meeting.

18. STANDING FOR VOTING:

A Member who has had a standing of atleast one full year as a Member of the Society and is not in arrears of his subscription, shall be entitled to vote at the General Body Meeting.


Academic year of the Society shall be from June to May such other period as may prescribed by the Executive Body from time to time.


23. TERM OF THE EXECUTIVE BODY:

27. FUNCTIONS OF THE EXECUTIVE BODY.


Fuctions of the Executive Body among other, shall be:

29. FUNCTIONS OF THE VICE PRESIDENT:


The Vice President shall in the absence of the President exercise the powers of the President.

30. FUNCTIONS OF THE GENERAL SECRETARY:


The functions of the General Secretary, among others shall be:-

31. FUNCTIONS OF THE JOINT SECRETARY:

The Joint Secretary shall in the absence of the General Secretary exercise such powers of the Secretary as delegated by him (General Secretary)

32. FUNCTIONS OF THE TREASURER:

- i. To receive amounts.
- ii. To arrange to deposit the cash balance of the Society in a Bank and not to retain more than Rs. 500/- in his custody, excluding the Office imprest which will be with the Secretary. He shall pay amount as per sanction of the Secretary.
- iii. To secure the pass books and cheque books and keep cash balance in safe custody and reconcile and tally the cash balance with the day book at least once in a month.

33. ASSETS AND FINANCES:

The Executive Body appoints an auditor or auditors who shall audit the accounts of the Society and put up before the General Body of the Society for consideration and adoption.


35. LIABILITIES OF THE MEMBERS:

The members of the Society shall not be personally liable for the re-imbusement of any debts and liabilities of the Society.




